

Business Overview (FY2024)

In FY2024, supported by the recovering Japanese economy, Tokyo Big Sight held various events throughout the year and welcomed visitors from abroad. In the Venue Operation Business, event hosting was booming, and our facilities were used for various purposes by many different promoters, resulting in favorable results such as new records for yearly total sales (Tokyo Big Sight, Ariake GYM-EX).

In the Exhibition Organization Business, we worked on numerous projects such as JIMTOF (Japan International Machine Tool Fair), which was held for the first time in two years, JA (Japan International Aerospace Exhibition), held for the first time in eight years, and yearly events such as RISCON TOKYO (Risk Control in Tokyo) and Tokyo Business Chance Expo.

In the Building Management Business, we increased opportunities for communication with resident tenants, strengthening relationships while simultaneously striving to understand and handle their needs. These efforts contributed to improved satisfaction rates. We also aimed for maintenance and improvement of occupancy rates and made efforts to provide flexible services in order to secure new tenants.



◆ Ariake GYM-EX

Ariake GYM-EX

As a legacy competition venue from the Tokyo 2020 Olympic and Paralympic Games, the Ariake Gymnastics Centre was renovated into an exhibition hall. The name for the facility, Ariake GYM-EX, expresses the location (Ariake), the former use as a competition venue (Gymnastics), and the current function (Exhibition). The exhibition hall has approximately 9,400 \mbox{m}^2 of total space and features 20-meter ceilings, giving a sense of openness due to the lack of support columns inside.





Year-Long Initiatives

The Tokyo Metropolitan Government launched a large-scale renovation project for the Conference Tower and West Exhibition Halls. (Scheduled completion date: December 2025)



• Implementation and testing of patrol security robots and virtual security systems

Moving toward the achievement of a security framework combining cutting-edge robot technology with human workers, we conducted verification experiments using self-driving patrol security robots, surveillance security cameras, and display-type virtual security systems with automatic guidance functions.





Fire and Crime Prevention Measures

• Self-defense fire drills, etc.

We held statutory self-defense fire drills twice in the year under review. Additionally, we conducted individual training through Tokyo Big Sight security staff such as training on contacting authorities, training on operating fire extinguishers, and training for dealing with suspicious persons. We also held joint self-defense fire drills with organizers. Through these activities, we worked to improve the safety and security of Tokyo Big Sight.

• Joint training for sudden events

On February 28, 2025, under the guidance and cooperation of the Metropolitan Police Department, joint training for sudden events during exhibitions was conducted covering how to deal with protest groups and suspicious items, as well as provide evacuation guidance. Facility and event security personnel participated in this joint training session to strengthen coordination and improve their response capability.







Stimulating the Liveliness of the Local Area

• Tokyo International Projection Mapping Awards Vol. 9 (November 16, 2024)

The 9th iteration of these awards, which utilized the wall surface of the Conference Tower, was viewed by approximately 12,000 people, the largest number in the event's history.


In addition, group company PR was implemented at the "Hospitality Booth" provided by Tokyo Rinkai Holdings Group, alongside free distribution of hot drinks.

At the TIME24 Building, we established a new exclusive tenant lounge space within the Seagull restaurant, ideal for uses such as internal meetings and coffee breaks. At the TFT Building, we installed Free Wi-Fi and drink machines in the exclusive tenant lounge in an effort to create an even more comfortable environment. At the Ariake Park Building, we carried out landscaping maintenance on the plants near the entrance, striving to improve the hotel's image. In addition, we refurbished some of the old equipment in the rental conference rooms in the TIME24 Building and TFT Building.

Initiatives to Increase Tenant Satisfaction

At the TIME24 Building, in order to improve satisfaction among the tenants, we updated the menu at the Seagull restaurant and introduced exclusive tenant pricing. In addition, since there are large numbers of visitors to the building during the new employee training season in the spring, we implemented measures such as limited-time food truck and boxed meal sales to improve dining services and avoid congestion at the restaurant.


